5. How to Enter

When the fee is received an Official Contest Answer Sheet will be mailed/emailed within 7 days. Limit one (1) entry per person, per email address, and per household for the duration of the Contest Period, regardless of the method of entry. Entries received from any person, e-mail address, or household in excess of the stated limitation will be void. All entries become the property of Sponsor and will not be acknowledged or returned.
